




Estimated Construction Project Timeline - 3/23



- Playground Accessibility and Fall Protection (March 2023). Work will be completed during the summer of 2023.
- Team evaluated three vendors for access control and security camera systems. Needs assessment being finished and preparing for Request for Proposal for top two to address access control and security cameras. Work will begin over the summer of 2023.




